#### RECOMMENDATION

#### Council resolves that:

- 1. The report of the Director City Assets titled "Extension of the 40km/hr Speed Zone on Semaphore Road" be received and noted.
- 2. A formal submission to the Department for Infrastructure and Transport (DIT) is made to progress with the extension of the existing 40km/hr speed zone (and associated infrastructure) on Semaphore Road (between Military Road and Swan Terrace).
- 3. The Mayor writes to the Local Member of Parliament providing details of this report including consultation results requesting support for the 40km/hr speed limit on Semaphore Road, with the response to this letter to form part of the application to DIT for the 40km/hr speed limit application.
- 4. Subject to approval from DIT for the implementation of the 40km/hr speed limit, that all residents and property owners in the subject area be advised accordingly.

## Report

At its meeting on 9 November 2021, Council resolved as follows:

- 1. '..the Director City Assets' report titled "40km/hr Speed Limit Considerations in Port Adelaide and Semaphore" be received and noted.
- 2. The implementation of a 40km/hr speed limit be further considered at the following locations: a. Semaphore Road (between Military Road and Swan Terrace); and b. throughout the Port Centre.
- 3. Speed and traffic volumes in the areas identified in (2) above be collected in accordance with the legislative requirements to consider such a speed limit and community consultation occur on such a proposal.
- 4. The results of the consultation be brought back in a subsequent report to Council'.

This report discusses the Semaphore Road aspect of this resolution (ie between Military Road and Swan Terrace; a distance of 450m). The 40km/hr within the Port Centre has been deferred to align with the Port Centre Local Area Traffic Management Scheme (LATM) – which will commence in mid-2023, and subsequently be reported to Council.

In accordance with the resolution above, staff further consulted with the impacted community along Semaphore Road via hand delivered letters to all impacted businesses, mail outs to property owners, corflute signs along Semaphore Road and use of the online 'Participate PAE' platform. This report discusses these results.

## Background




Figure 1 - Location Plan - Semaphore Road, Semaphore (Subject Area Shaded Red)

The western end of Semaphore Road from Military Road to the Esplanade is currently sign-posted as 40km/hr. Council received a request from the 'Semaphore Mainstreet Association' to extend the existing 40km/hr speed zone to capture most businesses along Semaphore Road. A location plan is provided as Figure 1.

In accordance with the Speed Limit Guidelines, a lower speed limit, such as a 40km/hr may be suitable for high pedestrian activity centres where high pedestrian and vehicle movements are generated consistently throughout the day and over the year. The roadside development may consist of retail shops, dining, entertainment, or recreation facilities on both sides of the carriageway, mixed with residential development, generating frequent pedestrian movements across the road. These requirements are present along this section of Semaphore Road (between Military Road and Swan Terrace)

## Community Engagement

We engaged with the community so they could provide their feedback in various ways.

#### This included:

- Hand delivered letters to all impacted businesses
- Mail out to property owners
- Corflute signs along Semaphore Road to capture pedestrians, shoppers and visitors to the area
- Promotion on our Participate PAE website, including an email blast to all users that had noted Semaphore as an area of interest
- Promotion on Council's social media platforms
- The Mayor spoke to this proposal on ABC radio

Copies of the engagement materials can be found in Attachment 1, 2 & 3.

This engagement strategy was effective as it included direct engagement methods for those located immediately along Semaphore Road, as well as broader methods to capture feedback from visitors to the area.

The engagement time frame was also extended to include the school holiday period, noting higher visitation rates of tourists during this time. A summary of the engagement results is provided in Table 1.

## **Analysis**

There was an overwhelming positive reaction to this proposal, with 81% support from the community.




Figure 2 – Survey Person Type ("Which Best Describes You?")

There was a high level of engagement from the corflute signs / online promotion as many identified as 'nearby resident' (49%) or 'visitor/shopper' (20%) who wouldn't have received direct access to a survey from the mail out. This is a key metric as this best captures how users and shoppers of the streets want the road to function. Figure 2 shows a breakdown of who completed the surveys.




Figure 3- User Type ("How Do You Travel Along Semaphore Road?")

86% of those who completed the survey indicated that they walk and 43% indicated that they cycle along Semaphore Road. There are notable benefits to these groups in reducing the speed limit. A summary of user type is provided in Figure 3.

The general themes that the community raised during the 40km/hr proposal is summarised in Table 2.

#### Hall Street

A group of nearby residents of Hall Street have raised concerns with this proposal as they believe that this will increase traffic numbers and traffic speeds along Hall Street. Staff are in the process of obtaining current traffic data for Hall St to establish the base operating conditions. We will continue to monitor traffic performance along Hall St and consider intervention if traffic conditions are assessed to be outside of acceptable levels.

Staff do not anticipate any adverse traffic impacts to Hall St because of this proposal. Reducing the speed form 50km/hr to 40km/hr is expected to add 8 seconds to the journey time. Evidence has shown in the Sefton Park area there has been negligible change in traffic volumes as a result of the 40km/hr speed limit in this area (which has been in place for approximately 3 years).

## Speed Limit Review Process

Council does not have the delegated authority to set or alter speed limits and is required to request approval from the Commissioner of Highways – Department for Infrastructure and Transport (DIT).

The 'Speed Limit Guidelines for South Australia' documents the speed limit review process. This process requires the following information to be submitted for assessment:

- Resolution from Council endorsing the proposed speed limit change;
- Indication of support from the local State Member of Parliament;
- A site plan accurately indicating existing speed limit signs, location of proposed speed limit signs, local roads, distances and any other relevant information, such as details of roadside development, parking controls, traffic signals, and existing and proposed physical speed control treatments or traffic calming devices;
- A traffic impact statement;
- The collection of speed data on 'relevant' streets (i.e., those streets longer than 250m) to meet required DIT criteria;
- Details of consultation completed with impacted stakeholders.

If approval is granted (via this report) to support the 40km/hr speed limit in Semaphore Road, then this information will be used to accompany the application.

## *Implementation*

Approval must be granted from DIT / Commissioner of Highways before a road authority can install, alter or remove a speed limit sign. Installation, alteration or removal of a speed limit sign without proper authority is an offence under section 21 of the Road Traffic Act 1961.

The implementation of new speed limits may also require the following measures to maximise effectiveness:

- Local media campaigns to reinforce/raise awareness of changed speed limits;
- Liaison with SAPOL to ensure appropriate enforcement;
- Use of variable message trailers for a brief period;
- Minor streetscape upgrades, which may include distinctive pavements and tree plantings within concrete medians at the eastern 'entry' of the proposed 40km/h area.
   This will define this as a low-speed environment for road users.

## **Next Steps**

With Council endorsement, staff will progress with the stages of implementation, seeking approval from DIT / Commissioner of Highways to alter the speed limit. Along with the detailed design of the entry treatment.

## City Plan Relationship

The proposed speed limit reduction to 40km/hr supports the keys themes of the City Plan of:

- Community We are a safe, vibrant, inclusive, and welcoming City for our residents, business and visitors alike. Improving road safety and encouraging greater nonvehicular travel helps create a sense of community.
- **Placemaking** we are a unique and distinctive collection of active places, created and cared for through strong partnerships. Creating low speed environments encourages more pedestrian movements and helps activate the streetscape.

## **Legislative Context and Related Policies**

Any consideration of a lower speed environment would need to be designed in accordance with the following legislation and standards:

- Speed Limit Guideline for South Australia (2017)
- The Department for Transport and Infrastructure's 'Manual of Legal Responsibilities and Technical Requirements for Traffic Control Devices' (The Code of Technical Requirements)
- Local Government Act (1999)
- Road Traffic Act (1961)
- Australian Road Rules (1999)
- Road Traffic Regulations (1999)
- Various Austroads Guidelines

## Stakeholder Engagement

Staff have completed community consultation. A summary of the community engagement outcomes and analysis has been detailed within the body of the report.

Overall, there was 81% support for lowering the speed limit to 40km/hr.

## **Risk Management**

Evidence has shown that there is a slight reduction in average speeds in a local area when a 40km/hr local area speed limit is introduced in isolation (for example, just changing the speed limit sign). The 40km/hr speed zone will be further enhanced with a 'threshold' treatment to indicate to the road user that they are entering a low-speed environment which will improve the effectiveness and compliance with the new speed limit.

## **Financial Management**

To support the proposed speed reduction along this section of Semaphore Road, it is recommended that some changes in the roadside environment are made to provide additional cues to motorists that they are within a low speed, high pedestrian activity centre. From preliminary investigations, this may include distinctive pavements and tree plantings within concrete medians at the eastern 'entry' of the proposed 40km/h area.

If this proposal is endorsed, detailed work will commence on the entry treatment.

Works will be funded under Council's "Hazardous Areas" budget line for 2023/2024 and are estimated to cost between \$50k-75k.

## **Environmental and Social Impacts**

From a social perspective, reduced speeds enhance pedestrian safety, encouraging people to walk, cycle, and engage in active transportation. This promotes healthier lifestyles, reduces traffic-related accidents and injuries, and fosters a sense of community as people have more opportunities to interact and connect with their surroundings. Lower speeds also contribute to a quieter and less stressful urban environment, improving the quality of life for residents, workers and visitors to the area.

In terms of environmental benefits, lower speed limits lead to decreased emissions and improved air quality. When vehicles travel at lower speeds, they consume less fuel, resulting in reduced greenhouse gas emissions and pollution. By encouraging alternative modes of transportation, such as walking, cycling, and public transit, lower speed environments also contribute to a decrease in overall traffic volume and congestion, further reducing emissions and promoting a greener, more sustainable urban landscape.






#### **Frequently Asked Questions**

#### Where are you proposing to implement the 40km/hr speed limit?

#### Why are we proposing to extend the 40km/hr speed limit along Semaphore Road?

Speed is a major factor in the severity of a crash involving a pedestrian and a car. If a driver hits a pedestrian while travelling at 50km/h, the risk of fatality to the pedestrian is doubled compared to what it would be if the driver had been travelling at 40km/h.

The faster you drive, the further you travel before you stop — and the harder you hit.

#### What are the benefits of the extended 40km/hr speed limit?

The key benefits of the 40km/hr speed zone on Semaphore Road are:

- Improved safety outcomes for road users, including pedestrians and cyclists, in what
  is an area of high pedestrian activity.
- Consistent speed zone along the commercial prescient along Semaphore Road.
- Improved opportunities for people to safely socialise and interact with local businesses.

#### What are the other impacts?

We will install additional signage to indicate the start and end of the speed zone.


