



Permits and Penalties By-Law	
Permits	New provision that allows permission to be given on a general (broad) basis by way of Council adopting a policy. The change is intended to create greater flexibility for the Council and ease administrative burden of issuing individual permits (where appropriate).
Moveable Sign By-Law	
Liability of Vehicle Owners	New provision that extends criminal liability for a contravention of the By-Law involving a vehicle to the owner of the vehicle. This relates to a moveable sign attached to a vehicle, primarily for the purpose of advertising. This operates similar to owner liability for parking offences under the Road Traffic legislation.
Local Government Land By-Law	
Horses on the beach	Remove specific times in By-Law to enable Council to regulate times through resolution.
Aquatic Life	New provision to regulate the introduction of any aquatic life into any waters.
Boats and Mooring	Changed wording to provide greater control and flexibility for Council to declare areas where launching or mooring of a boat can occur without a permit.
Camping	Removed from Local Government Land By-Law and new Camping By-Law created.
Golf	Reworded so golf can only occur on a golf course or land determined by Council through resolution.
Rubbish Bins	New provision to ensure the correct waste is placed in the correct Council rubbish bins on Local Government Land
Special Event	Amended definition of special event to mean an organised gathering of more than fifty (50) persons for any social, sporting or cultural purpose. This allows events for less than 50 people, which are not weddings or funerals, or where a marquee, structure, or stage is required, or for commercial purposes to occur without the need for a permit.
Wheeled Recreational Devices	New provision to regulate the use of wheeled recreational devices on Local Government Land.
Liability of Vehicle Owners	New provision that extends criminal liability for a contravention of the By-Law involving a vehicle to the owner

	of the vehicle. This operates similar to owner liability for parking offences under the Road Traffic legislation.
Roads By-Law	
Camping	Removed from Roads By-Law and new Camping By-Law created.
Advertising	New provision to regulate the display of advertising on roads (other than a moveable sign placed in accordance with moveable sign by-law).
Rubbish Bins	New provision to ensure the correct use of bins on roads, particularly where recycling bins are further introduced. It enables enforcement action to address incorrect use of a bin.
Liability of Vehicle Owners	New provision that extends criminal liability for a contravention of the By-Law involving a vehicle to the owner of the vehicle. This operates similar to owner liability for parking offences under the Road Traffic legislation.
Dogs By-Law	
Children's Playground	The distance dogs are prohibited from an unenclosed playground extended from 3m to 5m to provide a greater comfort and safety for children playing.
Foreshore	Remove specific times that dogs must be on leash on the foreshore to enable Council to regulate times through resolution.
Waste Management By-Law	
Removal of bin	Revised so that bins must be removed from the road no later than 11.59pm the following day after collection and allows bins to be placed out the night before the collection day.
Animal Management By-Law New By-Law that is proposed to be introduced to regulate the keeping of roosters and more than 2 bee hives in residential areas	
Rooster	<p>New provision that prohibits a rooster from being kept on a residential property or within 100 metres of the boundary of neighbouring residential premises without council permission.</p> <p>This change is to ensure that roosters are only kept on such premises with a permit that requires adequate steps be taken to address associated noise and reduce their impacts on the community.</p>
Bee Hives	<p>New provision that imposes a limit of 2 beehives that can be kept on a property without permission. This is consistent with PIRSA limits for small properties.</p> <p>This approach is intended to strike the balance between allowing beehives to support sustainable living choices, and the need to ensure bee numbers do not become excessive so as to cause adverse impacts on neighbouring land.</p>

Caravan and Camping By-Law

This By-Law regulates camping on Local Government land and roads. It enables the Council to determine, by resolution, areas where camping may be permitted.

This proposed By-law consolidates the camping provisions previously included in the Local Government land and Roads By-laws.
